

Photograph and Image Use Policies

The Cape May County Historical and Genealogical Society (identified as The Society henceforth) supports and encourages access to the materials in our collections. While The Society owns the object, we may not be the holder of the copyright. Consequently, The Society does not assume responsibility for literary property, copyright, or any other legal property involved in the reproduction or the publication of items from its collections. This includes all documents, photographs, maps, and works of art. The applicant must assume all responsibility for securing permission from the appropriate copyright holder if publication is planned.

Permission to use materials from The Society collections does not give the applicant exclusive rights to the material, nor the right to manipulate or crop the item without explicit permission, nor does permission include future re-use of the material. Each new use requires a new Use Agreement.

Reproduction Policies

1. Written permission must be obtained from The Society for any reproduction of print, media, and/or imagery held in The Society collections.
 - 1.1. Written permission is granted via the Use Agreement Form provided by The Society.
2. The person signing the Use Agreement Form is responsible for the Conditions for Reproduction.
 - 2.1. This form acts as the contract and invoice between The Society and the Applicant.
3. Each new use requires a new Use Agreement Form.
 - 3.1. For example, if original request was for personal use but the applicant has decided to publish the images in an online blog, the applicant must complete a new Use Agreement Form before doing so.
4. Reproductions may not be transmitted to other individuals, groups, or institutions.
5. Reproductions may not be duplicated without written permission via a new Use Agreement Form.
6. Reproductions may not be made publicly accessibly online without explicit permission from The Society Board of Trustees.
7. When reviewing materials in-person, no flash drives or storage devices are permitted, nor can patrons email photos or images to themselves.
8. Patrons may not use their own scanners or cameras to copy/photograph images.
 - 8.1. Scanning, photographing, and copying will be done by staff only.
9. Fees are charged for reproductions.
 - 9.1. In addition to the fee to use each image, there is an additional service charge for the time it takes our staff to locate and/or research images.
 - 9.2. For large/extensive files, a thumb drive will be mailed containing files at the applicant's expense.
 - 9.3. Commercial use of images is subject to additional fees and restrictions.

10. All fees must be paid in full prior to receiving reproductions.
11. If an item is fragile, the staff may not scan/photograph it at their discretion.
12. Not all items will be made available for reproduction and/or publication.
13. The Society must be credited on or next to each image or film clip as "The Cape May County Historical & Genealogical Society" (and photographer/artist credit if applicable).
 - 13.1. Digital reproductions for personal use will be watermarked by The Cape May County Historical & Genealogical Society.

Additional Policies Concerning the Publication of Reproductions

1. A publication is defined as any published reproduction of an image such as: printed reproduction, book, periodical, flyer, published film or online/digital content.
2. Permission is granted only for one usage in the Publication in one edition and in one language.
 - 2.1. Any subsequent use (including new editions, paperback editions, foreign language editions, etc.) constitutes reuse and must be applied for in writing to The Society through a new Use Agreement Form.
 - 2.2. An additional fee may be charged.
3. Permission granted is for the reproduction and publication of the image in published formats only, including published versions of film or online/digital publications.
 - 3.1. Applicant may only make digital copies as absolutely necessary in intermediate process steps to the creation of a book, periodical, or published film.
 - 3.2. The Society does not otherwise grant permission to reproduce or process any item in any digital format (including websites). Such permission must be obtained separately in writing.
4. Objects appearing in the images, even if owned by The Society, may be protected by copyright, publication rights, or related interests that are not owned by The Society.
 - 4.1. The Society does not give permission to exploit any third-party rights. The applicant will ascertain whether any such rights exist, pay any royalties or fees claimed by any third party and obtain all other permission required to carry out applicant's activities without infringing the proprietary rights of, breaching duty to, or breaching an agreement with, any third party.
 - 4.2. Applicant will indemnify, defend, and hold The Society harmless from all costs, charges, fees, or expenses (including attorney fees), losses damages, liabilities, or judgements arising from or relating to any claim, cause, or allegation asserted by a third party against The Society based entirely or in part on applicant's exploitation of the items permitted for use hereunder.
5. Reproductions must remain unaltered and in entirety unless approved in writing by The Society.
 - 5.1. Reproductions may not be cropped, bled off the page, guttered across facing pages, or printed on colored stock or with colored ink, nor may anything be superimposed or graphically altered on reproductions.
 - 5.2. When a detail is used, the word "detail" must appear in the credit line.
6. Except as described below, the credit line and the copyright notice must appear on or with the item in the publication.

7. The Society reserves the right to limit the number of reproductions of The Society owned property in any single publication, if it appears that their number is disproportionate in relation to those from other sources.
8. No Permission granted pursuant to this application may be assigned by applicant.
 - 8.1. This application and any attached and cross-referenced pages sets forth the entire agreement of The Society and applicant regarding the item(s) identified on this application, and supersedes all prior promises, representations or statements of any kind, whether written or oral.
 - 8.2. This application may only be modified in writing signed by the authorized representative of The Society and expressly stating its intention to modify this application.
 - 8.3. This application will be governed by the law of the State of New Jersey without regard to its conflicts of laws principles.
9. The reproduction permission granted hereby is limited to a nonexclusive reproduction solely on the terms set forth herein.
 - 9.1. The Society retains all copyright ownership and all rights to exploit its copyrights.
 - 9.2. All rights not expressly granted herein are reserved to The Society.
 - 9.3. If reproduction is to be made from materials depicting The Society's property but not supplied by The Society, The Society reserves the right to approve these materials.
10. Applicant will obtain The Society's prior written approval of final presentation of item(s) prior to general distribution or publication of the Publication.
 - 10.1. The applicant must submit publications for review prior to publishing and send a complimentary copy to The Society once complete.
